2	School is not running balvatika in the school as recommended by NCF. School is directed to run at least 01 section each of balvatika I, II & III in accordance with established norms permitted vide Board's circular no. 12/2023 dated 24-03-2023 & 25/2023 dated 11-09-2023.
3	As per the recommendation of NEP, the school shall ensure the participation of its students in Structured Assessment for Analyzing Learning (SAFAL), an exam conducted by the Board every years as per the guidelines issued by the Board vide circular no:- Acad-49/2024 dated 26th June 2024.
4	The school shall ensure the implementation of the Holistic Progress Card (HPC) for the foundational stage in the school as per the guidelines issued by the Board vide notification no. CBSE/Director (AcadAssessment)/2023 dated 27.12.2023.
5	The school shall insure to conduct at least 50 hours of Continuous Professional Development (CPD) every year for all the teachers vide notification no. 16/2021 dated 24.09.2023 out of which 25 hours should be from COE Pune.
6	The school shall submit an undertaking with regard to uploading completely all requisite information regarding students, teachers and infrastructure details available in the school on the UDISE Portal and OASIS Portal. The registration of the students in classes IX and XI shall be conditional on the school providing complete information on UDISE and OASIS Portal.
7	Sports ground of 3300 Sq. Mtr. added by the school as seen in video @1:38 and reported by the IC allotted to School by the trust through a resolution dated 9/7/24. But the same has not been registered with the Competent Authority. School shall complete the formality of the registration etc. and obtain the revised valid land certificate from the concerned authority within 03 months and submit as compliance on SARAS portal.
8	ICT infrastructure is not developed in the library. Space for project and activity is not available. Separate reading area for staff is not developed. School shall install ICT infrastructure to cater the need of access digital/cloud reading material and upgrade the library in the light of SoP issued by the Board within 03 months and submit compliance.
9	Other required facilities such as LMS, Webcam, interactive Board, projector are also not available in the lab. School shall install the computer chair with furniture and upgrade the lab in the light of SoP issued by the Board within 03 months and submit compliance on SARAS portal.
10	Few dimension shapes and few kits are placed on a table as makeshift arrangement in math lab. Proper storage, adequate seating and activity tables are not available in the math lab to accommodate 40 students at a time and conduct activities. School shall setup both labs in the light of SoP issued by the Board within 03 months and submit compliance on SARAS portal.
11	As reported by the Inspection Committee school shall reconstitute the School Management Committee as per suggestion of the IC and in the light of affiliation by elaws of the Board within 03 months and submit the same under compliance on SARAS portal.

Compliance of the above mentioned points shall be submitted within 03 months on the SARAS Portal. Failure to comply within the prescribed time shall invite financial penalty @ Rs. 50,000/- every month until compliance is submitted and shall debar the school from filling the registration and LOC of students class IX to class XII, as the case may be.
